



## Accreditation guide lines

Please send your signed and completely filled out accreditation form together with a copy of your official press card for 2009 as well as your editorial assignment either per email, fax or post to the contact address stated below.

Before signing the accreditation agreement (liability declaration) for the JIM CLARK-REVIVAL 2009 in the media centre, you must present your official press credentials.

**Please note that you must present the following documents in the media centre at the EuroSpeedway Lausitz before your JCR-Pressticket can be handed out to you:**

- Official press card 2009 in original from a valid journalist association like the DJV, DJU, AIPS, VDM, etc. (only press cards valid for the current year will be accepted).
- Original or copy of your editorial assignment for the JIM CLARK-REVIVAL 2009 with a current date and signature of the Chief Editor or Head of Department. Alternatively, supporting documents (articles, photographs) together with clear proof of origin can also be presented. The presented documents will be then be checked.

The number of press representatives who can accredit for an editorial media is dependant on the kind and on the number of copies sold or the coverage involved. As a rule, only one accreditation per editorial department is allowed. However individual cases can be examined by the SCHÖNER LEBEN MARKETING GMBH if necessary.
